
1. I am the petitioner in the above captioned cause of action.
2. I am an Individual In Custody under the custody, care and control of the Illinois Department of Corrections, and currently housed at the Hill Correctional Center, Galesburg, Illinois 61402.
3. That I, the Petitioner, wishes to file with the U.S. Supreme Court a Petition For Writ of Certiorari.
4. The Petitioner has previously requested for an extension of time to file his Petition For Writ of Certiorari, and on December 6, 2021, the Honorable Justice Barrett granted Petitioner's request and set a due date for the petition of February 4, 2022, in Application Number 21A210.

5. On January 05, 2022, the Hill Correctional Center faced a 'massive surge' in Covid-19 infections among staff and the inmate population, which has caused the prison to be placed on a 'medical lockdown'!

6. Due to the 'medical lockdown' of the Hill Correctional Center, the Petitioner has lost all access to the prison's Law Library to conduct research and make copies in preparation of filing his Petition Writ of Certiorari with this Honorable Court.

7. The Hill Correctional Center's 'medical lockdown' due to the 'massive surge' on Covid-19 infections is beyond the control of the Petitioner, and respectfully requests the Court's understanding of the situation faced by this Petitioner.

WHEREFORE, the Petitioner, Steven A. Taliani, pro se, respectfully requests this Honorable Court to grant his Motion For Extension of Time due to the unforeseen circumstances that have risen, and provide the Petitioner for an additional 60 days to file his Petition for Writ of Certiorari.

Dear Mr. Levitan,


