- ④ If an Inmate Falls From a Top Bunk and is taken to the Hospital and is sent back to the prison with several injuries to the head, neck shoulder and hip ect and put back on the same top bunk he or she fall from even though he has a bottom bunk pass and shouldnt be on a top bunk to start with, is that a constitutional violation?

STATEMENT OF THE CASE

I was in federal prison and because i have a lot of physical injuries to my body i was given a bottom bunk pass. i have had lower back surgery, i have a pin in my left femur, my leg is numb from my knee down to my toes and my right shoulder is hurt to the point that i might lose the use of using it. I ~~had~~ have been on a bottom bunk for several years while in the BOP and FCI Gilmer camp in June 2019 and was left on the top bunk even after i fall and was hurt. I begged the medical staff to move me long before i fall and they chose to leave me in harms way until i wrote a BP on the medical staff then and only them did i get moved to a bottom bunk and because of the fall, took, injured my head, neck, back, eye, hip, and other parts of my body. I have the paper work that shows i shouldnt have been on a top bunk but they put me there anyway, and even after i fall, was put back on the same top bunk for another 6 days before i was moved to a lower bunk and from the first day i got to the prison until i left there they had at least 10 or more bottom bunks open at all times. And the staff at FCI Gilmer camp put guys on the lower bunks that didnt have a lower bunk pass and left me and left me in harms way thank you.

REASONS FOR GRANTING THE PETITION

1 Because my constitutional Rights was violated when i was put in harms way and then put back in harm way even after i fall and got hurt for another 6 days.

CONCLUSION

The petition for a writ of certiorari should be granted.
