The defendant, DAVID LOPEZ, was represented by Richard L. Jewkes.


The defendant was found guilty by jury verdict after a plea of not guilty to Counts 1 and 2 of the Indictment on January 25, 2017. Accordingly, the defendant is adjudged guilty of such Counts, involving the following offenses:

21 USC 846 & 841 Conspiracy To Possess W/Intent To Distribute A Controlled Substance, to-wit: Marijuana > 1,000 Kilograms	August 22, 2015	1
21 USC 841 Possession W/Intent To Distribute A Controlled Substance, To-wit: Marijuana > 100 Kilograms	August 21, 2015	2

As pronounced on June 2, 2017, the defendant is sentenced as provided in pages 2 through 9 of this Judgment. The sentence is imposed pursuant to the Sentencing Reform Act of 1984 and the Enhancement of Punishment Information filed May 18, 2016.

It is further ordered that the defendant shall notify the United States Attorney for this district within 30 days of any change of name, residence, or mailing address until all fines, restitution, costs, and special assessments imposed by this Judgment are fully paid. If ordered to pay restitution, the defendant shall notify the Court and United States Attorney of any material change in the defendant's economic circumstances.
