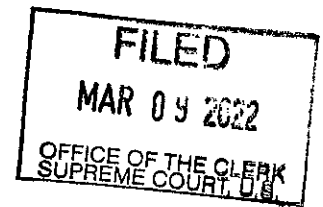

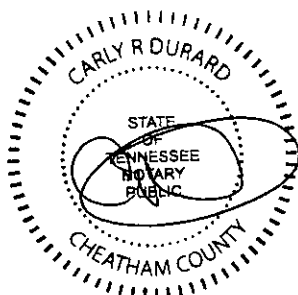
12. Provide any other information that will help explain why you cannot pay the costs of this case.

After my release from the second false imprisonment on April 23, 2019, I lived in a transitional house paying rent. Once I filed the lawsuit, due to the tremendous expensive legal fees, I was forced into a homeless shelter.



12. Due to the negative stain that's currently on my record from the wrongful conviction, it's very hard getting a better job with higher pay raise. Every business does a background check. As this Court understand, legal fees are very expensive. If I had to pay rent on an apartment or home, I would not have been able to afford to pay for my legal fees in this matter to get back my liberty, inheritance, and job as Trustee. I had A-1 credit along with a legal sustainable earning before I endured being kidnapped and false imprisonment under the Color of Law. The very first illegal incarceration set me back tremendously financially which also resulted in my credit being downgraded to a negative. As mentioned in the Writ, once released from the first illegal confinement, I filed a Civil Rights complaint under the Color of Law to the Department of Justice. DOJ informed me I needed to retain an attorney to represent me before them. I retained two attorneys Samuel Rael and Samuel Hamilton. Together those two attorneys refiled the complaint to the Department of Justice. DOJ responded through verbal communication and through correspondence letters for us to report to the FBI with all the evidence. I was also assigned a Federal Case Agent. The Federal Case Agent tried on numerous occasions, made numerous attempts to work with those attorneys. Samuel Hamilton and Samuel Rael refused to cooperate in this case and refused to cooperate with the Federal Case Agent assigned. The Federal Case Agent informed me those attorneys were paid off. After I received that information and realizing those attorneys were not doing anything but stalling my case by not cooperating, and not living up to the duties we agreed to in the contract, I informed both attorneys I was going to file a complaint against them if they didn't cooperate and live up to the contract we agreed too. Once I filed the complaint against Mr. Hamilton, he sent me a termination letter stating, "Due to the fact I filed a complaint against him, he going to terminate our services." The Maryland Grievance Committee reprimanded Mr. Hamilton (BC Docket No. 2019-1715). Neither attorney reported to the FBI as ordered by the Department of Justice. I reported to the FBI on my own.

Currently, I make \$10.50 hr at Goodwill, and only have \$1400.00 in cash that's in the bank. I tried very hard and worked very hard to pay for my legal fees all the way up to this point which left me homeless. The cost of the 40 copies of petition in booklet format along with 40 copies of the appendix, and copies going to the Respondents are virtually too much for me to handle at this moment. I was quoted prices in ranges from \$1500 to \$2500 to get this done. I just don't have the money to pay for cost moving forward. I hope this Court understand.
