To the Honorable Clarence Thomas, Associate Justice of the Supreme Court of the United States and Circuit Justice for the Eleventh Circuit:

Introduction

Pursuant to this Court's Rule 13.5, the Petitioner, Gilberto Mulgado, respectfully requests a twenty-day extension of time within which to file a petition for a writ of certiorari in this Court, to and including March 17, 2022.

Jurisdiction

The opinion of the Florida Second District Court of Appeal affirming the Petitioner's conviction was entered on August 18, 2021. The order of the Florida Second District Court of Appeal denying rehearing was entered on October 28, 2021. The original deadline by which to file a petition for a writ of certiorari was January 26, 2022. This Court extended the deadline by thirty days to February 25, 2022. Undersigned counsel is requesting an additional twenty days by which to file the petition for a writ of certiorari.

The jurisdiction of this Court is invoked under 28 U.S.C. § 1257. Copies of the opinion and the order of the Florida Second District Court of Appeal are included in the appendix to this motion.

Argument

The Petitioner will be seeking certiorari review on the following issue: whether the trial court erred by allowing the State to introduce repetitive child hearsay statements at the Petitioner's trial.

Undersigned counsel had intended to complete the petition in this case during the week of February 14, 2022. However, on February 12, 2022, undersigned counsel learned that his uncle (the Honorable William Batchelder of Ohio) passed away, and, as a result, undersigned counsel will be out of his office during the week of February 14, 2022, attending the funeral in Ohio.

Therefore, the Petitioner requests an additional extension of twenty days to file the petition for a writ of certiorari.¹ No party will be prejudiced by the granting of a twenty-day extension in this case.

Accordingly, the Petitioner respectfully requests that an order be entered extending the time to petition for writ of certiorari by an additional twenty days.


