IV Petition for Writ of Certiorari

I, Linda Jolly, a Federal Government Employee reported this case to the United States Court of Appeals, Fourth Circuit. The case was denied on August 26, 2021 due to not filing on time according to Rule 13 U.S.C&210© Untimely Rule 30.2. Reason for the timely issue is because I received the denial verdict from the United States District Court of Maryland in 2021, but the denial was made in September of 2020.

V. Opinion Below

The decision by the United States Court of Appeals, Fourth Circuit of Maryland was denying the direct report that Linda Jolly vs. Carmelita White and Daniel Everett (Fed.R.App.P.41) Maryland App. August 26, 2021. (Appendix A)

The Decision by the United States District Court of Maryland was denied because they do not investigate cases. (Appendix B)

VI. Jurisdiction

Linda Jolly's Petition for hearing to the United States Appeals Court, Fourth Circuit was Denied on August 26, 2021 due to timely filed. Rule13 U.S.C. & 2101©. Untimely Filed under Rule 30.2.

VII. Constitutional Provisions Involved

United States Constitutional, Amendment XIII

The United States Constitutional, Amendment XIII (January 31st, 1865 to December 6st, 1865) the abolishment of slavery (freed slaves) in the United States of America.

I, Linda Jolly a United States Federal Government Employee was unable to help from the United States Federal Government to stop the harassment from Carmelita White and Daniel Everett. Number of times I have contacted United States Federal Government Official Offices and Maryland State Official Offices for help and I was denied. No Federal Government Employee should have endured what I had to endure over twelve years. I was violated as a Federal Government Employee, as a Taxpayer and a Citizen of the United States of America.

United States Constitution, Amendment XIV

The United States Constitutional, Amendment XIV (Year 1868) Equal Rights by the United States Constitution granting Citizenship and equal civil and legal rights to African Americans.

I, Linda Jolly as an African American was not treated fair by the United States Federal Government as a Tax Payer, Citizen and a Federal Government Employee, because they allowed my Federal Government and Maryland State Income Taxes to be pulled, copied, and shared by Carmelita White and Daniel Everett among their friends. When I searched for legal help and paid fees, I was told that they cannot get involved. I approached Two Lawyers for Federal Government help Attorney David Love and Attorney Andrew M. Dansicker,LLC.

I, Linda Jolly contacted EEOC twice and was denied due to the person involved. Somehow when Carmelita White's name was mentioned no one wanted to help me.

I, Linda Jolly contacted Senate Office McCaskill's Official Affairs for Federal Government Affairs (Saundrea) shropshire@hsgas.senate.gov

Under the Whistleblower's Law (IRM 25.2.1.) Filled out form 11369 and sent back to office. No recognition, no awards given and Confidentiality never took place.

VIII Statement of the Case

I am sending this Petition to the Supreme Court of the United States in Washington, D.C. because I endure harassment sometimes unbearable at times due to the United States Federal Government ignoring me and not resolving my case issue.

I was pulled into the Federal Examination Office in Baltimore, Maryland about my Federal Income Taxes, and I Passed the Federal Examination.

My Bi-weekly pay was not correct and I informed my Supervisor Sangita Kumar. We addressed the issue with Human Resources and they brushed it off.

During the years 2014-2020, my Bi-Weekly Pay was different amounts I worked 80 hours every two weeks and I had to pay Federal Income Taxes even though I claimed zero (0) all year.

I logged into my (EPP) Employee Personal Page, I notice that my account was changed and someone has claimed one (1) between (2014-2015). I changed it back to zero (0) between (2015-2020). I still had to pay Federal Income Taxes from (2014-2020).

I did some research on my Personal Information and found out that Carmelita White (Federal Employee) and Patricia Pierce's (National Finance Center Employee) names were on my SETR Account. I did more research and found out that money was taken from my account before Transmitted to my Direct Deposit Account at the Bank of America. My (EPP) Employee Personal

Page and my Direct Deposit were different amounts. I was always missing at least over One Hundred and Seventy-Five Dollars every two weeks.

In 2014 I went into my Thrift Savings Account and Borrowed some money for Financial Hardship. 20% of my money was supposed to go to the United States Federal Government but it did not. I marked off 20% on my application when I logged on the Website. (\$2,800.00) Two-Thousand, Eight Hundred Dollars was missing. I had to do another Withdrawal from the Federal Thrift Savings and same thing happened in 2016.

1. UNAXLAW

(IRM10.5.5) Disclosure (IRM4.19.10.3/IRM25.15.1.2/IRM5.19.1.2.2(2)

Daniel Everett began yelling that he pulled up all my Maryland State Income Taxes (2000-2020). Carmelita White pulled up My Federal Income Taxes (2000-2020). I went to EEOC, OCS, Justice Department and other Federal Government Authorities and I was rejected.

Civil Rights Act 1964

I purchased ADT Camera & Alarm System because I found out the Carmelita White and Daniel Everett purchased Surveillance Cameras. They Know everywhere I went inside my home and outside my home. Every day, I log onto my Laptop for Work and Daniel Everett would call his from the yard and ask them to kick my off the Network, or Turn off my Gas & Electric. In the

Winter Time it is Cold and in the Summer Time it is Warm. My bills are paid monthly on time.

I went to purchase legal help from Attorney David Love, he is told not get involved because it was Federal Government Business. I went to another Attorney Andrew M. Dansicker, LLC. and he did not follow because he was told not to get involve. I found myself without help, so I went to the emails sent to Senator McCaskill's Official Senate Office of Federal Government Affairs office. Saundrea Shropshire@hsgac.senate.gov . HSGAC Minority Office back in 2017. They were told by Former President Barak Obama not to process my claim but to just put a "W" on her badge so that the Federal Government would not help me. Carmelita White keeps telling them they she wants to rob my home and take everything and get away with it. They are still thinking about it since she still has Surveillance on my home. I have been blacked balled in the Federal Government.

2. Federal District Court of Maryland

I sent my case to the United States District Court of Maryland, 101 West Lombard Street, Baltimore, Maryland 21201, Case # 1:20-cv-02505ccb. My experience at the Federal Court was to send information that pertains to my case, after I sent the information nothing was done they stated that they do not investigate cases. Former United States President Barak Obama told them not to get involved. I did not receive a reply from the Federal District Court of Maryland until 2021 but the decision was made September 2020.

3. Direct Appeals

I sent my case to the United States Court of Appeals, Fourth Circuit, 1100 East Main Street, 5th Floor, Richmond, Virginia 23219, Case # 21-1195. I directed my case to the Court of Appeals because as a United States Federal Government Employee my rights have been violated. I mailed over thirty pieces of Document and I kept calling the court house speaking to Ms. Susan and she assured that the Judge will process my case. Later, I heard Former President Barak Obama say that he does not want them to get involve with this case! My right to legal help is being violated! The Court of Appeals did not allow me to challenge my Case because of the timing. Due to the COVID-19 my mail would not come on time or never. My claim was Denied.

4. Conclusion

In conclusion, for this reason I am sending my Petition to the Supreme Court of the United States. I pray that my case will be investigated, and I will get to challenge my case in Court against Carmelita White and Daniel Everett. I pray that the Supreme Court of the United States will enforce Federal Laws that are in placed but ignored. I, Linda Jolly go through bullying and harassment every day and night. Due to the United States Federal Government Not paying attention to this case Carmelita White has access to all of my Accounts: (EPP) Employee Personal Page, Human Resources, Direct Deposit in the Bank of America and other bank accounts,

My Sprint Smart Phone, ADT & WYZE Home Security and a Master Key to
my home along with surveillance Cameras. Please accept my Petition.

IX. REASONS FOR GRANTING THE PETITION

My Reason for granting my Petition is to get The Supreme Court of the United States to hear my case and investigate the allegations put before you. U.S. Court of Appeals, Fourth Circuit denied my case 8/26/21 due not filing on Time. I want The Federal Supreme Court of the United States to enforce the United States Federal Laws (UNAX, Disclosure, Fraud) against the Parties (Carmelita White & Daniel Everett) for breaking these Federal Laws. I believe that as a Citizen of this United States, I have a Right to live in Peace in my home without harassment from others. If you accept my Petition, the United States Supreme Court will be sending a message to Every U.S. Federal Government Employee that they have a voice and when Retaliations from the U.S. Federal Government occurs, they are Protested by the Federal Laws of this United States Federal Government.

Harassment (Management Abuse)

The harassment continues to get worst due to the non-response from the United States Federal Government.

Retaliations: (No Fear Act)

I should not be treated by the United States Federal Government as though I have done something BUT I did Nothing!

UNAX Laws and Disclosure Laws (IRM10.5.5) (IRM 25.15.1.9.2/IRM 4.19.10.3):

Carmelita White went outside of the Federal Government to have Daniel Everett pull up my Federal and State Income Taxes. My Private Personal Tax Information, make copies and show others my information. UNAX Law (IRM 10.5.5) is unlawful for a Federal Government Employee or and Outside individual to pull up Income Taxes on a Federal Government Employee Tax Payer without the Proper Paperwork or with the willful intent to harm. It holds a penalty of up to \$5,000 per income Tax Form and One Year Prison. Carmelita White had no paperwork. TIGTA did nothing to Daniel Everett. Carmelita White pulled up my Federal Government Income Taxes shared with outside and gave my neighbor Daniel Everett who had no permission to pull up my State of Maryland Income Taxes: 2001-2020.

Cyber Space Laws:

Carmelita White began playing on the laptop as I start my work day. I would get kicked off the Network, Denied Access to IRS VPN ERAP. Once I was logged on they would Switch Screens on Documents and move the mouse several times. They would delete ICONS from my Desktop and Shutdown Several Machines that I do not have access to delete Icons, but while I am doing my IT Specialist work interruptions happens. I informed the Cyber Space Manager at IRS Twice. Carmelita White uses CITRIX to take control over my laptop through her Administration Access and kicks me off my IRS Laptop several times, still today.

Civil Rights Act of 1964 and WhistleBlower Law (IRM25.2.1):

I went to get legal help from a lawyer with the information I had gather and the lawyers were told that the United States Federal Government would handle it, so the lawyers would turn down my cry to get help. The Lawyers were told that this was a Federal Government matter. I had already paid one lawyer a fee. So I contact the Maryland State Senate Office and Internal Affairs for Federal Government Affairs. I have emails sent to Senator McCaskill's Official Senate Office of Federal Government Affairs office. Saundrea Shropshire@hsgac.senate.gov . HSGAC Minority Office back in 2017. I filled out forms and sent information about my case. My badge changed with (W) but the Senate office were told not help me. I was black balled in the Federal Government and I was told by my Manager Ms. Sangita, that the Federal Government will not help me and I would have to go outside to get some help.

I tried to get all of the twelve years in this letter as much as possible, I have sent over one hundred letters, forms, & emails to every Maryland State, Local, and Federal Office. I did nothing wrong but the United States Federal Government treated as though I did. The Federal Government did not send Carmelita White after me, she came on her own as judge, jury and executor without giving me the right to defend myself except once through my Federal Tax Examinations, and I had passed the Federal Tax Examination

My Experience with the U.S. District Court of Maryland was somewhat cold. I was told to send the letters of information to prove that there was some type of harassment. When I sent the letters from the Official offices of the State of Maryland and Official Offices of the United States Federal Government, I was told that the U.S. District Court of Maryland does not investigate any cases and I was denied any services or help.

Then I went to another Court
