Before the panel of Randolph, C.J., Beam and Chamberlin, JJ., is the motion to dismiss indictment filed pro se by Delbert Keyes, Jr, on November 25, 2019. Said motion is in the nature of a motion for post-conviction relief, and it is treated as such. Keyes subsequently filed a supplement to his motion on January 13, 2020.

Keyes was convicted of robbery, kidnapping, and forcible sexual intercourse. For each count, he was sentenced to life without eligibility for parole in the custody of the Mississippi Department of Corrections as a habitual offender under Mississippi Code Annotated, section 99-19-83 (Rev. 2015), with the sentences to run consecutively. His conviction and sentence were affirmed on direct appeal, and the mandate issued on May 14, 2019. *Keyes v. State*, 2018 WL 6323115 (Miss. Ct. App. Dec. 4, 2018), cert. dismissed, 276 So. 3d 660 (Miss. 2019). This is Keyes's first motion for post-conviction relief and it was timely filed. Having duly considered the filing, the panel finds no merit to the claims. Accordingly, the panel finds the motion and the supplemental filing should be denied.

IT IS THEREFORE ORDERED that the motion to dismiss the indictment and the



Before the panel of King, P.J., Coleman and Chamberlin, JJ., is the Application for Leave to Proceed in the Trial Court filed pro se by Delbert Keyes, Jr. Keyes was convicted of robbery, kidnapping, and forcible sexual intercourse. For each count, he was sentenced to life, without the eligibility for parole, in the custody of the Mississippi Department of Corrections as a habitual offender under Mississippi Code Annotated, section 99-19-83 (Rev. 2015), with the sentences to run consecutively. His conviction and sentence were affirmed on direct appeal, and the mandate issued on May 14, 2019. *Keyes v. State*, --- So. 3d ---, 2018 WL 6323115 (Miss. Ct. App. 2018), cert. dismissed, 276 So. 3d 660 (Miss. 2019). This is Keyes's second motion for post-conviction relief, and the panel finds it to be successive, without exception. Miss. Code Ann. § 99-39-27(9). Notwithstanding the procedural bar, the panel finds no merit to the claims raised. Accordingly, the panel finds the motion should be denied.

IT IS, THEREFORE, ORDERED that the Application for Leave to Proceed in the Trial Court is denied.


