RE: APPEAL BOND

Defendant posted appeal bond of \$4,000 along with an Authorization for Return of Cash Bond Following Appeal and a "Notice of Appellant Bond Posting by Appellant for the Sole Purpose of Stopping the Implementation of the Low Court's Evil Agenda. Demand for the Return in Full in Cash of Appellant's Posted Cash in the Amount of \$4000 at Conclusion of Appeal in Full Return of Posted Amount Isn't (sic) Accomplished Prior to the Conclusion of Appeal.

Defendant has crossed off mandatory portions of the Authorization Form. Defendant is attempting set her own terms concerning the authorized use of appeal funds and declaring herself "EXEMPT" from Iowa law as to its use. Defendant makes further demands and attempts to set terms by way of the referenced "Notice." Defendant has not agreed to the statutory requirements.

Therefore, the court does not accept the appeal bond and the clerk is directed to return the funds to the Defendant.

Mittimus remains October 7, 2021 at 10 am unless the Authorization Form is completed correctly without modification and bond posted.
