

VERIFICATION IN ABSENCE OF NOTARY

I, THOMAS CARL BRUNI, am an incarcerated inmate under the custody and control of the New York State Department of Corrections and Community Supervision, (D.O.C.C.S.), and my ability to acquire the services of a Notary Public is entirely under the control of prison officials. Contrary to the edict of the United States Supreme Court in Bounds v. 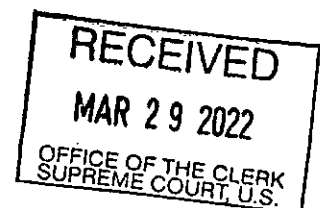
