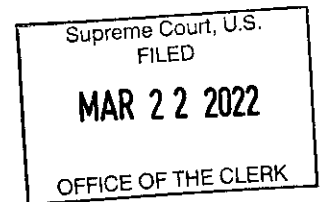

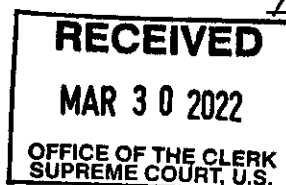

ORDER GRANTING MOTION TO PROCEED INFORMA PAUPERIS

The Court is in receipt of Plaintiff/Petitioner MICHAEL B. BYNOE's *Motion to Proceed Informa Pauperis* and *Affidavit of Poverty* filed May 12, 2020. This matter was submitted to the Court for its consideration on August 26, 2020. Upon review, this Court finds that pursuant to NRS 12.015 and Nevada Supreme Court Order ADKT No. 411, Plaintiff/Petitioner's *Motion to Proceed Informa Pauperis* is sufficient to grant forma pauperis status at this time.

THEREFORE, pursuant to NRS 12.015, Plaintiff/Petitioner MICHAEL B. BYNOE's *Motion to Proceed Informa Pauperis* is **GRANTED**.

IT IS HEREBY ORDERED that the Court allow the Plaintiff/Petitioner to proceed without payment of fees or security thereof;

IT IS HEREBY FURTHER ORDERED that the Clerk of the Court shall file and process all pleadings necessary in the prosecution of this action without fees;

IT IS HEREBY FURTHER ORDERED that the Sheriff effectuate personal service of any necessary pleadings or papers for the Plaintiff/Petitioner in this action without charge.
