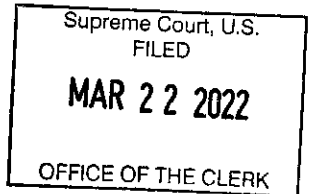

# POLITICAL HISTORY

I was adopted by way of these Courts (Exhibit 5.1) for being born ten years to the day after American soldiers paraded before DeGaul (Exhibit 5.2a, 5.2b). Born with the expected birthmark warranted by the DeGaul photo (Exhibit 5.3a) I had enablers (Exhibit 5.3b) to get me through life. My mother's maiden name Herbert (Exhibit 5.4) is Acadian for 'Chief of the Army' as one George Herbert Walker Bush was. My first rite-of-passage at age 5 dealt with the Fuhrer's Eagle's Nest. My second rite-of-passage there in Saint Albans Queens in Trinity Lutheran Church of Locust Manor, had a man take me from my father's hand and lead me to the basement. Here I was seated before my very first white man who then proceeded to psychoanalyze me without one word said between us. My third rite-of-passage, designed to give me Trimethylaminuria would make me st[ink] like ink, up to the age of 50 (Exhibit 5.5a, 5.5b).

In the 70s and in my teens, I one day took a trip with my cousin Joseph King, to pick up his pay check at Creedmoor State Hospital. Here four patients put me through a skit involving the sentence "this is my K, this is my machine gun". I would learn years later a K-gun is something on a submarine. Also during the 70s 007 actor Richard Kiel (Ex 5.6) suggested I go to Alaska. Being thrown this curve out of nowhere was alright, because in 64 at Grace Lutheran Day School, 5th grade, I drew a train coming out of a tunnel. Nevada's State Seal has a train coming out of a tunnel. Government / Soda-Science knew by this drawing I would make my way back to Nevada someday.

In the 80s at a Court ordered program in Anchorage, I would see the Shuttle fly for the first time. I found out then that I could push a piece of gum through my gaped front teeth to make a shuttle

Shaped piece of gum, delta wing and all. I at an early age had fallen off my bicycle (Exhibit 5.7a-5.7c) to chip the corner of a tooth to make the delta wing. Dentist Sawangskin said he didn't need to cap it. I learnt here in prison I have rapport with Field Marshall Mont[go]mery and Mont[go]mery Wards, just as Sudo-Science would have it.

Back in the lower 48 in Corpus Christi Tx, I saw an ELL a right angle lines sky phenomenon. Returning to Carson City, Carson wanted me to remember right away the phenomenon. Subsequently I would go on to have a 30 year memory suppression of the ELL phenomenon. Thanks to being in one place, prison, I came to remember, and hence I now can Expand the Records with esoteric facts of ELL (Exhibit 4.2)

## REASONS FOR GRANTING THE PETITION

The immunity provided for actions taken in good faith Wood vs Strickland 420 US 308 (1975) underscores that constitutional torts are attuned more to the nature of the official's act than the degree of harm to the plaintiff

However Fed's acting in Good Faith can still be liable for injury and damages

As for Judges and Paralegals being or not being with invidiously discrimination animus, government employees allowed immunity in a case should not be allowed in this case due to ADA provision §12202 Appendix C.1
