

### **STATEMENT OF THE CASE**

The basis for federal jurisdiction is under 28 U.S.C -1254, the Rules of the Supreme Court of the United States, this matter of case caption Damilola Animashaun v. Correctional Officer Regner is a federal matter since this matter originally in the federal Courts accrued in the U.S. District Court Northern District of New York (federal court).

## REASONS FOR GRANTING THE PETITION

The reasons the Writ is to be granted are: 1) There are submitted documents of papers I filed in the U.S. District court Northern District of New York with the Complaint which such papers are the immediate medical check-ups and medical diagnoses I was involved with as a result of the assault by defendant against I.
