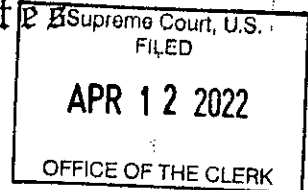

I also owe \$4,203.56 in child support to the state of North Dakota. I have never had at least \$300.00 in my possession which is the fee for this filing. For these reasons I cannot pay the costs of this case.

I also sell my Inmate Commissary Account spending limit where someone deposits funds on my account and I go shopping for them, I get an average of \$20.00 out of the deal every two-weeks, this is what accounts for the bulk of my Inmate Account Deposits(Gifts)(See Attachment- Inmate Account Statement)
