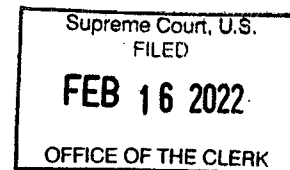

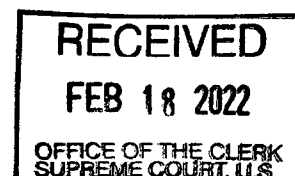

Unsworn Declaration Under Penalty of Perjury
