**ORDER GRANTING DEFENDANT'S MOTION  
TO APPOINT COUNSEL ON APPEAL [100]**

After pleading guilty to felon in possession of a firearm, possession with intent to distribute heroin, and conspiracy to engage in sex trafficking, Defendant Erskin Perryman was sentenced on March 29, 2021. He filed a notice of appeal on April 5, 2021. (ECF No. 98.) Presently before this Court (rather than the Court of Appeals), is Perryman's motion to appoint counsel on appeal. (ECF No. 100.) Perryman advises that he is unable to afford counsel to handle his appeal. (*Id.* at PageID.727.)

Having considered the motion and supporting financial affidavit,

It is ORDERED that retained counsel's request to withdraw is GRANTED.

It is further ORDERED that the Federal Community Defender Officer is again appointed to represent Perryman and may assign appellate counsel in its discretion.
