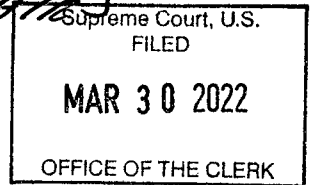

QUESTIONS PRESENTED

1. BOTH THE FIFTH CIRCUIT AND THE U.S. SOUTHERN DISTRICT COURTS HAVE DISAGREED WITH THE NINTH COURT OF CRIMINAL APPEALS IN THAT BOTH HAVE QUOTED THAT THE THREE-STRIKES PROVISION APPLIES TO FIRST AMENDMENT CLAIMS ACCORDING TO THE PRISON LITIGATION REFORM ACT (P.L.R.A.)
