ORDER:

William Siskos moves for a certificate of appealability (“COA”) in order to appeal the district court’s denial of his *pro se* Fed. R. Civ. P. 60(b)(3) motion for reconsideration of the denial of his amended 28 U.S.C. § 2254 petition. To obtain a COA, Siskos must make “a substantial showing of the denial of a constitutional right.” 28 U.S.C. § 2253(c)(2). Because Siskos has failed to make the requisite showing, his motion for a COA is DENIED. Accordingly, his motion to proceed *in forma pauperis* on appeal is DENIED as moot.

Those points were either made by Mr. Siskos earlier in the litigation, or could have been presented earlier in one of the prior post-collateral proceedings, including the instant, denied petition. The motion cites no proper grounds for relief under Fed. R. Civ. P. 60(b)(3) and is denied. The Court finds the Rule 60(b)(3) motion to be without merit, and therefore denies a certificate of appealability as reasonable jurists would not contend the motion presents a colorable grounds for relief. ENDORSED ORDER denying [61] Motion.
Mr. Siskos asserts a Fed. R. Civ. 60(b)(3) motion seeking relief from judgment
due to fraud upon adverse party. The Court has reviewed the motion and finds
it without merit. The motion first asserts that Mr. Siskos' habeas
corpus petition was insufficiently reviewed and not thoroughly adjudicated
by the District Court. Mr. Siskos complains that the petition was not referred
to a Magistrate Judge for a Report and Recommendation that he could have
responded to. He argues that the matter was handled in a discriminatory
fashion. The petition was reviewed substantively and on the merits by both
the District Court and the Court of Appeals. The latter affirmed denial
of relief. The Rule 60(b)(3) motion also recites various statements made,
primarily by State agents about movant's mental state and competency,
that were false. Those points were either made by Mr. Siskos earlier in
the litigation, or could have been presented earlier in one of the prior
post-collateral proceedings, including the instant, denied petition. The
motion cites no proper grounds for relief under Fed. R. Civ. P. 60(b)(3)
and is denied. The Court finds the Rule 60(b)(3) motion to be without merit,
and therefore denies a certificate of appealability as reasonable jurists
