ORDER GRANTING PETITION FOR WRIT OF POSSESSION


THIS CAUSE being heard on the 11 day of September, 2015 on the Plaintiff's

(2) Mail or take a copy of your written reason(s) to: CARL WASILESKI, Attorney for Plaintiff, 507 Palm Avenue, Titusville, Florida 32796.

IF YOU DO NOT DO ALL OF THESE THINGS WITHIN 5 WORKING DAYS AFTER THE DATE THAT THESE PAPERS WERE GIVEN TO YOU OR TO A PERSON WHO LIVES WITH YOU OR WERE POSTED AT YOUR HOME, YOU MAY BE REMOVED WITHOUT FURTHER NOTICE.

County, Florida, further described as:


Lot 15, Block 1808, Port Malabar Unit 42, according to the Plat thereof
