**MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS***



**DECLARATION IN SUPPORT OF**  
**MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS***

I, Dana Albrecht, am the petitioner in the above-entitled case. I was the defendant in the case below. In support of my motion to proceed *in forma pauperis*, I state that because of my financial circumstances I am unable to pay the costs of this case or to give security therefore; and I believe I am entitled to redress.

1. I am presently unemployed, have no substantial income of my own, and rely on financial support from my father.
2. I have been unemployed since April 8, 2016, at the commencement of my family law case.
3. I am presently divorced. My ex-spouse, Respondent in this case, has not provided to me any recent disclosures concerning her own financial circumstances.
4. I have minimal cash on hand.
5. I have no substantial assets and substantial debt.
6. I have no debts owed to me.
7. I pay \$50 per month in child support to my ex-spouse for support of our youngest minor child.
8. I own a single vehicle, a 2011 Honda Accord with over 200,000 miles. I have substantial monthly expenses, including \$2,500 in rent, reasonable costs for food, and other reasonable living expenses.



9. I do not anticipate any substantial changes in my income or expenses over the next year.
10. I now represent myself, *pro se*, in all underlying related family law cases, including the New Hampshire trial courts, the New Hampshire Supreme Court, and related UCCJEA trial court dockets in California and Michigan. No attorney has assisted with the preparation of my petition in this Court for this case.

11. I anticipate reasonable printing, photocopying, and postage costs in connection with this case, and will be paying the costs thereof.
12. However, I cannot afford to pay for the typesetting, printing, and binding of 40 copies of my petition, and in particular, its appendix, in 6 $\frac{1}{8}$ -inch by 9 $\frac{1}{4}$ -inch booklet format pursuant to Rule 33, nor can I afford to pay for legal representation.
