APPLICATION FOR AN EXTENSION OF TIME

Pursuant to Rule 13.5 of the Rules of this Court, Applicant Femi Isijola hereby requests a 60-day extension of time within which to file a petition for a writ of certiorari up to and including Monday, May 9, 2022.

JUDGMENT FOR WHICH REVIEW IS SOUGHT

The judgment for which review is sought is a civil case between Femi Isijola v. Director, New Hampshire Division of Motor Vehicles, No. 2021-0045 (November 18, 2021) (attached as Exhibit 1). The Supreme Court of the State of New Hampshire denied Applicant's motion for reconsideration or rehearing on December 9, 2021 (attached as Exhibit 2).

JURISDICTION

This Court will have jurisdiction over any timely petition for certiorari in this case pursuant to 28 U.S.C. § 1257(a)). In this case under 28 U.S.C. §1257(a)), the Supreme Court of the State of New Hampshire issued NO opinion despite my request to do so with a Motion for Reconsideration on November 23, 2021. Under Rules 13.1, 13.3, and 30.1 of the Rules of this Court, a petition for a writ of certiorari was due to be filed on or before March 9, 2022. In accordance with Rule 13.5, this application is being filed more than 10 days in advance of the filing date for the petition for a writ of certiorari.

REASONS JUSTIFYING AN EXTENSION OF TIME

Applicant respectfully requests a 60-day extension of time within which to file a petition for a writ of certiorari seeking review of the decision of the Supreme Court of the State of New Hampshire in this case, up to and including May 9, 2022.

1. I have lost my Stepdad due to death caused by Covid and I am involved in the preparation and the execution of a befitting burial for my Stepdad and the extension of time will give me time necessary to complete this cogent petition.
2. I would not have asked for this 60-day extension request, but only for the loss of my Stepdad who was very instrumental to my upbringing in this life, and I am taking leadership on the preparation of a befitting burial for my Stepdad. The extension of time will give me adequate time to complete this petition.
3. A 60-day extension for me will allow me the necessary amount of time to effectively contribute to all open matters including this petition as well as the burial of my Stepdad.

For the foregoing reasons, Applicant Femi Isijola respectfully requests that this Court grant an extension of 60 days, up to and including May 9, 2022, within which to file a petition for a writ of certiorari in this case.
