Before: McKEOWN, CHRISTEN, and BRESS, Circuit Judges.

A review of the record and the parties' responses to this court's March 2, 2022, order to show cause demonstrates that the court lacks jurisdiction over these consolidated appeals because the district court's "Order Revoking Defendant's Pro Se Status, Denying Pending Motions, and Continuing Sentencing Hearing" is not appealable as a final judgment or an order that comes within the collateral order doctrine. *See* 28 U.S.C. § 1291; *Flanagan v. United States*, 465 U.S. 259, 267-68 (1984) (observing that post-conviction review of an order implicating the Sixth Amendment right to self-representation is "fully effective"). We accordingly dismiss.

All pending motions are denied as moot.
