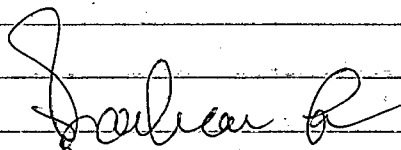

NOW COMES PETITIONER, BARBARA FRANTZ, BY PRO SE, A PARTY UNREPRESENTED BY COUNSEL, PRESENT IN GOOD FAITH AND NOT FOR DELAY. PRAYING UPON THIS SUPREME COURT OF THE U.S. FOR REHEARING MAKING SUMMARY JUDGMENT INAPPROPRIATE, HOLDING LIFE INSURANCE PROCEEDS IN COURT REGISTRY BARRING CONTINGENT BENEFICIARY, PATRICK FRANTZ, RESPONDENT FROM LIFE INSURANCE PROCEEDS PURSUANT TO K.S.A. 59-513 AND COMMON LAW WHICH BARS THE BENEFICIARY OF A LIFE INSURANCE POLICY WHETHER CONVICTED OR NOT. 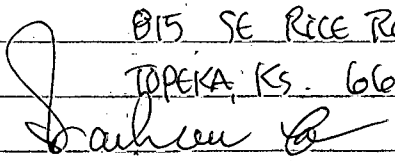
