COMES NOW, Latoya Nicole Carter, currently released upon an appeal bond from the Lynchburg Circuit Court and a resident of Lynchburg, Virginia, by and through her court appointed counsel, Matthew L. Pack, hereby requests leave to proceed *in forma pauperis* in connection with his Petition for Writ of Certiorari.

Pursuant to Rule 39.1 of the Rules of the United States Supreme Court, Ms. Carter seeks this motion to proceed as indigent and has enclosed a notarized affidavit in accordance with 28 U.S.C. § 1746 (Exhibit A). On September 16, 2019, the Honorable F. Patrick Yeatts, Presiding Judge, of the Lynchburg Circuit Court substituted and appointed Morgan Hollister, Esq., as indigent, court appointed counsel, pursuant to Virginia Code § 19.2-159, as amended; then on April 28, 2022, the Honorable F. Patrick Yeatts further appointed Matthew L. Pack, Esq. as court appointed counsel for the indigent Ms. Carter (collectively, Exhibit B).

Furthermore, Ms. Carter has represented to undersigned counsel that she does not have sufficient funds to hire counsel to assist her with this matter. Thus, it is counsel's belief that Ms. Carter continues to be indigent, based on his previous qualification for counsel at public expense.





