
CAME NOW the Petitioner and prayed the Court to reconsider its decision to enter an order of demurrer in this matter,

IT APPEARING TO THE COURT that the Petitioner has failed to allege a cognizable cause of action.


THE PETITIONER'S motion is denied and the Court's December 9, 2021, order sustaining the respondent's demurrer of this matter remains in effect.
