
PETITIONER'S AMENDED MOTION FOR  
LEAVE TO PROCEED *IN FORMA PAUPERIS*

The *pro se* petitioner, John P. Tomkins, hereby responds to the Court's 10/\_\_\_\_/22 Order\* directing Petitioner to either submit an amended motion for permission to proceed *in forma pauperis* or pay the Court's docketing fee by 10/24/22.

As an initial matter, Petitioner offers his sincere apology for the insufficiency of his original Motion for Leave to Proceed *In Forma Pauperis*. Petitioner's lay understanding of S.Ct. Rule 39.1 led him to believe that referencing the fact that the U.S. District Court had appointed counsel to represent him under the Criminal Justice Act of 1964, 18 U.S.C. § 3006A, would be sufficient to satisfy Rule 39 ("If the court below appointed counsel for an indigent party, no affidavit or declaration is

required, but the motion shall cite the provision of law under which counsel was appointed, or a copy of the order of appointment shall be appended to the motion.")


Obviously, Petitioner should have presented more than a bare-bones statement that "he was represented by appointed counsel pursuant to the provisions of the Criminal Justice Act of 1964, 18 U.S.C. § 3006A."

Rather than waste the Court's time with a lengthy analysis of the confusing procedural history concerning Petitioner's *in forma pauperis* status and the U.S. District Court's appointment of counsel, see Exhibit 1, Petitioner will simply amend his motion for leave to proceed *in forma pauperis* including a 6 month statement of his Trust Fund account and a completed "Form 4," which is attached as Exhibit 2.

WHEREFORE, the *pro se* Petitioner, John P. Tomkins, hereby moves the Honorable Court to accept this amended Motion for Leave to Proceed *In Forma Pauperis*.
