

Arizona state prisoner Demetrius A. Wilson appeals pro se from the district court's judgment dismissing his 42 U.S.C. § 1983 action alleging retaliation, deliberate indifference to serious medical needs, unconstitutional conditions of confinement, and due process claims. We have jurisdiction under 28 U.S.C. § 1291. We review for an abuse of discretion a dismissal under Federal Rule of Civil Procedure 41(b) for failure to comply with a court order. *Pagtalunan v. Galaza*, 291 F.3d 639, 640 (9th Cir. 2002). We affirm.

The district court did not abuse its discretion in dismissing Wilson's action

** The panel unanimously concludes this case is suitable for decision without oral argument. See Fed. R. App. P. 34(a)(2).

because Wilson failed to respond timely to the district court's order to amend the complaint despite being warned failure to comply would result in dismissal. *See id.* at 642-43 (discussing factors to consider in determining whether to dismiss for failure to comply with a court order and noting that dismissal should not be disturbed absent "a definite and firm conviction" that the district court "committed a clear error of judgment" (citation and internal quotation marks omitted)).

We do not consider Wilson's contentions relating to his motion for reconsideration because that issue is outside the scope of this appeal.

We do not consider matters not specifically and distinctly raised and argued in the opening brief, or arguments and allegations raised for the first time on appeal. *See Padgett v. Wright*, 587 F.3d 983, 985 n.2 (9th Cir. 2009).

All pending requests are denied.

15 Before the Court is Plaintiff Demetrius Antwon Wilson's Motion to Stay
16 Proceedings to Amended Case until Ninth Circuit Give[s] Ruling on Interlocutory Appeal
17 in Case 21-15840 Due to the Complication in this Above Case. (Doc. 45.)

18 In general, even when a party's interlocutory appeal of an order of this court is
19 filed, "the district court retains jurisdiction to continue with other stages of the case." *Plotkin v. Pac. Tel. & Tel. Co.*, 688 F.2d 1291, 1293 (9th Cir. 1982). In addition, the
20 Ninth Circuit already denied Plaintiff's interlocutory appeal, making the motion to stay
21 moot. *See Wilson v. Shinn*, No. 21-15840 (9th Cir. June 11, 2021).

22 Moreover, Plaintiff was previously warned in parallel proceedings that if the Court
23 has not issued a final order, an interlocutory appeal is inappropriate. *Wilson v. Shinn*, No.
24 CV-19-00257-RCC, Doc. 62 (D. Ariz. Feb. 7, 2020). Furthermore, Plaintiff has had
25 several interlocutory appeals dismissed as premature. *See e.g., Wilson v. Ryan*, No. 19-
26 15889, Doc. 4 (9th Cir. June 3, 2019); *Wilson v. Alvarez*, No. 16-16707, Doc. 2 (9th Cir.
27 Oct. 18, 2016); *Wilson v. Alvarez*, No. 16-16540, Doc. 2 (9th Cir. Sep. 23, 2016); *Wilson*

1 *v. Ryan*, No. 15-17032, Doc. 4 (9th Cir. Nov. 17, 2015). Plaintiff had fair notice that a
2 request for a stay was inappropriate and was unlikely to be successful. Therefore, the
3 Court declines to stay or extend deadlines in this matter.

4 Accordingly, IT IS ORDERED Plaintiff's Motion to Stay Proceedings is DENIED.
