

STATEMENT OF THE CASE

I very clearly asked Attorney James Millikan, working with the office of Public Defender in Montgomery County of Maryland, not to touch me again when he touched me first time while discussing the case. 

Statement of Facts





3. No one should have right / authority to play with my modesty only because they are powerFOOL or they have support of PowerFOOL people like in my case are James Millikan and Brian Fosk.


