Petitioner Serge Francois, through undersigned CJA counsel, moves the Court pursuant to Rule 39 of the Rules of the United States Supreme Court, for leave to proceed *In Forma Pauperis* on this Petition for Writ of Certiorari, Revised to comply with page length. As good grounds in support of this motion Petitioner states:

Confirmation of Appointment as CJA Appellate Counsel for Serge Francois

Confirmation of appointment as counsel on direct appeal for Mr. Francois is documented by attaching the following at the end of this motion: three pages from the docket sheet for the Eleventh Circuit Court of Appeals, Appeal No. 18-11165, reflecting that on May 3, 2018, the Eleventh Circuit appointed undersigned counsel to represent Serge Francois for purposes of his direct appeal.

As demonstrated by the foregoing document, Mr. Francois was found to be indigent in the district court in April of 2018, and he has been represented on appeal by undersigned counsel continuously since May 3, 2018.

Factual and Procedural Background

The record reflects that Mr. Francois and five codefendants were indicted in the Southern District Florida and charged with numerous counts of healthcare insurance fraud and money laundering. Serge Francois and one other defendant, Patrick Tonge, proceeded to a jury trial on a 48-count Fourth Superseding Indictment. Following a lengthy trial, the jury returned a verdict finding them both guilty.

Mr. Francois was sentenced to prison for a total of 204 months (17 years). He is presently incarcerated at Yazoo City FCI Low, with a presumptive release date in the year 2031. Mr. Francois was a licensed pharmacist. This case involved compounded medications each costing thousands of dollars, sent to military service members (and their families members) who were covered by the TRICARE federal military health insurance program through the Department of Defense. The losses to the government in this case were claimed to be over \$31 million dollars.

Mr. Francois' financial status has not improved since he has been incarcerated over the past several years.

Meritorious Issues Raised in the Petition

The Petition that is filed on behalf of Mr. Francois presents two meritorious questions for this Court’s review, including matters that require this Court to exercise its supervisory power over a decision of the Eleventh Circuit that departs from essential requirements of law in that it erroneously affirmed convictions for allegedly lying on pharmacy recredentialing forms. The answers he provided were truthful, but the questions were poorly written and failed to give definitions for the information that was requested. Throughout trial the government made comments and innuendos to make the truthful answers appear to be intentionally untruthful. There was no hidden agenda.

Also, over defense objection the court permitted a government “expert” to testify about pharmacy practices and procedures that were not enacted until after the alleged offenses occurred, thus resulting in convictions that violate Ex Post Facto prohibition in the Constitution, Article 1, Section 9, Clause 3, and Fifth Amendment Due Process.

Accordingly, for the foregoing reasons, Petitioner Serge Francois respectfully prays that this Honorable Court will grant this motion and will allow him to proceed

before this Court on Petition for Writ of Certiorari *In Forma Pauperis* through his CJA-appointed counsel.
