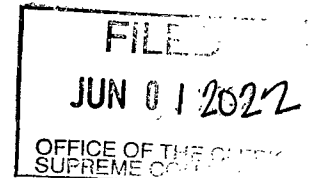

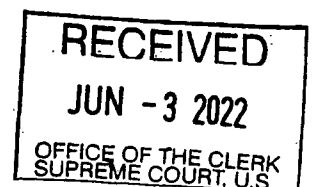
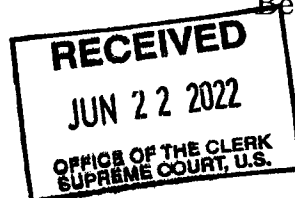
COMESNOW Daniel Louis Jackson # 16958-029 appearing Pro Se, respectfully
