Sushila,

I spoke with someone at the DMV about your tickets. The bad news is that the City is rather inflexible with regard to its settlement policies. It won't waive the penalties, and it doesn't take into account the customer's individual circumstances when working out settlements. The good news is that there are steps we can take to reduce the financial burden of the tickets.

There are two options: signing up for a payment plan or requesting a settlement.

If you sign up for a payment plan, you'd be required to provide 25% of the total amount owed (\$784) up front, and then asked to pay the remaining amount in monthly increments of \$392 over the course of the next six months. Although this option would not reduce the total amount owed, it would spread out the debt into (somewhat) more manageable payments.

If you request a settlement, you could reduce the total amount owed by 25% (bringing the new total to **\$2351**), but you would be required to pay that reduced amount in a lump sum. So while this option would lighten the financial burden, it would still require a fairly large payment up front.

We can discuss which, if either of these options would be worth exploring, but I wanted to give you the lay of the land.
