

Leeds's recent notice of his Petition for Writ of Certiorari to the Supreme Court of the United States, and the Court's inquiry regarding Respondent's interest in responding thereto.

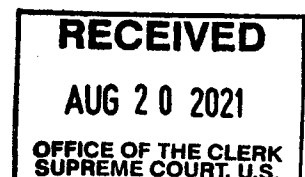
