I have represented 42 USC § 1983 Plaintiff Donald A. Vanderveer in this case since it began. His Petition for Writ of Certiorari was filed on January 10, 2022.

Mr. Vanderveer passed away on the evening of January 30, 2022. I enclose a copy of the funeral home's notice to support this suggestion of death on the record. I have read SCOTUS Rule 35, and I will comply with it as soon as I am able to do so. I do not yet have a copy of the death certificate, so there is nothing further I can do right now. Yesterday I informed my opposing counsel Mr. Scott Kreppein, and also Mr. Oren Zeve (of the New York State Attorney General's Office), of Mr. Vanderveer's passing. This Court shas et a deadline for the Respondents' response to the Petition, however, the Court may wish to consider imposing a "pause" to the scheduling of the response and the Petitioner's anticipated reply to it, in light of this Suggestion of Death on the record.
