

Motion for 24-Days Writ Extension

Due to an indigent and unrepresented status in prior appeals, petitioner is following the Court's "Guide for Prospective Indigent Petitioners for Writs of Certiorari." The Guide, however, does not detail time extension motions; therefore, petitioner is able to follow Rule 30.2 plus 30.3 (made 10-days prior to an individual Justice and served on all parties) and Rule 22.2 (original plus two copies with proof of service) but not all of Rule 33 (can comply with font face and size but not booklet format) for this motion. With the Court's permission, petitioner will identify the key elements for a time extension from the Texas Rule of Appellate Procedure 10.5(b) as guidance or a template for this particular time extension motion.

Per TEX. R. APP. P. 10.5(b),

1. the deadline of 90-days for a writ of certiorari from the U.S. Fifth Circuit is November 21, 2021, and the 10-days sooner deadline for a time extension is November 11, 2021;
2. an extension of 24-days to file a writ of certiorari up to and including Wednesday, December 15, 2021 is requested for Cause No. 20-50070 *only*;
3. the facts that follow explain why this extension is needed.



- a. the 90-days deadline for petitioner's first writ of certiorari (Cause No. 01-19-00024-CV) starts on July 30, 2021 and the second writ of certiorari (*this* Cause No. 20-50070) starts on August 23, 2021 with a difference of 24-days;
- b. nationwide labor shortages and work demands as a forklift driver only permit petitioner two or three days per week of free time to devote to this case;
- c. shut-down or limited access to law libraries because of ongoing COVID-19 concerns creates further delays; finally,

4. despite both deadlines to complete two writ petitions (extension not needed for first writ, Cause No. 01-19-00024-CV), this is petitioner's first motion for extension from this Court by only the 24-days difference between the two writ deadlines.
