
Dear Clerk of the Supreme Court,

Our real library and law library is still closed due to the corona quarantine lockdown. Without adequate guidance and example how can I possible file something without the know-how. The appellate court (11th Circuit) affirmed my sentence and conviction on October 8th, 2021 which mean my 90 days to file the writ is just over 70 days. Due to the library being closed I don't have the access to typewriter - I don't think the writ can be submitted in hand written - can it? Please kindly provide me guidance or point me to a resource to help me file my writ of Certiorari. Also please construe this as my motion for extension of time of 30 days. With the corona lock down still in place, the prison mails being

delayed I doubt 30 days will be enough just to gather information to file the paper. But any how please grant me until February 28th, 2021, to file my writ. Hopefully soon the prison lockdown will end or you'll be able to help me to get the help I need. I am penniless but will work hard to fight for my freedom and what is fair.



Motion for Extension of Time

On August 20th, 2021, the United States 11th Circuit Court of Appeal affirmed the district court's decision in Mr. Vorasiangsuk's criminals case. On October 8th, 2021, the appellate court denied Mr. Vorasiangsuk's Motion for Rehearing. At this time Mr. Vorasiangsuk requests the Supreme Court additional times until February 28th, 2022 to file his Writ of Certiorari. Currently, the prison that he resides in is still under a COVID-19 lock down. There is no access to the library, the typing room, the copy machine, and the actual physical law library. The law library program that the prison provides on a single computer to be shared by 160 + inmates in the unit does not contain adequate instruction on how to file a Writ of Certiorari. Without adequate information it is nearly impossible to complete a meaningful legal work. In fact the reason Mr. Vorasiangsuk's Motion for Rehearing was denied is because his motion exceeds the number of page allows per the court rule. The court rejected it without even reading the content - all because Mr. Vorasiangsuk did not have the adequate access to learn about the court rule. Without the access to the legal rules and information it would be hard to complete a motion correctly. Mr. Vorasiangsuk is intended to file for a Writ of Certiorari and he need to have the access to the legal resource that would tell him how to craft and file the writ correctly. With the extra time he will try to reach out to his family and ask them to find him some information about how to file for Writ of Certiorari. Mr. Vorasiangsuk is doing this pro se because he is indigent. He spent every thing he had and more on the legal fee. Included with this motion is the information of his financial status for the past six months as a proof to ask this court to also allow him to proceed in forma pauperis.

Under these circumstances Mr. Vorasiangsuk requests the Supreme Court to grant him until February 28th, 2022 to file his Writ of Certiorari.
