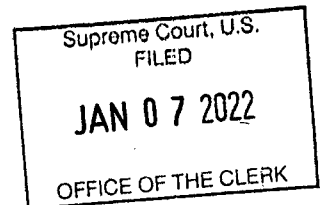

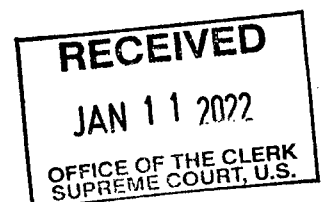

APPLICATION FOR AN EXTENSION OF TIME

Pursuant to Rule 13.5 of the Rules of this Court, Applicant Maurice Oparaji hereby requests a 60-day extension of time within which to file a petition for a writ of certiorari up to and including Monday, March 14, 2022.

JUDGMENT FOR WHICH REVIEW IS SOUGHT

The judgment for which review is sought is Maurice Oparaji, Me & You Biotech Inc v. MAR Acquisition Group, LLC, TAG Development, LLC, No. 21-2552 (September 15, 2021) (attached as **Exhibit One**). The United States Court of Appeals for the Third Circuit denied Applicant's motion for rehearing or modification on October 14, 2021 (attached as **Exhibit Two**).

JURISDICTION

This Court will have jurisdiction over any timely filed petition for certiorari in this case pursuant to 28 U.S.C. § 1254(1). Under Rules 13.1, 13.3, and 30.1 of the Rules of this Court, a petition for a writ of certiorari was due to be filed on or before

January 14, 2022. In accordance with Rule 13.5, this application is being filed more than 10 days in advance of the filing date for the petition for a writ of certiorari.

REASONS JUSTIFYING AN EXTENSION OF TIME

Applicant respectfully requests a 60-day extension of time within which to file a petition for a writ of certiorari seeking review of the decision of the United States Court of Appeals for the Third Circuit in this case, up to and including Monday, March 14, 2022.

Applicant filed a Complaint of Judicial Misconduct with the Office of the Circuit Executive, the United States Court of Appeals for the Third Circuit (**Exhibits Three and Four; see also Exhibit Six**) and with the Office of attorney ethics/attorney grievance, Supreme Court of New Jersey (**Exhibit Five**). These Offices have not completed the investigation; I am awaiting the release of a copy of a report of a special committee under section 353(c) (Margaret A. Wiegand (215) 597-0718). An extension of time will be necessary to enable me to receive a report of a special committee under section 353(c) to prepare and include a petition for writ of certiorari. An extension will not cause prejudice to Respondent, will ensure Fair Justice.


Conclusion
