COMES NOW WASSIM BAKER, PETITIONER ABOVE-SIGNED, AND PURSUANT TO U.S. SUPREME COURT RULES 13.5, 22, AND 30.3, APPLIES FOR A SIXTY(60)-DAY EXTENSION OF TIME TO FILE HIS PETITION FOR WRIT OF HABEAS CORPUS, AND SHOWS AS FOLLOWS:

1. ON AUGUST 16, 2021, THE ELEVENTH CIRCUIT AFFIRMED PETITIONER'S APPEALS. BAKER V. COMM'N, GA DEPT OF CORRECTIONS, ___ FED. APPX ___, NOS. 19-11723, 19-11849 (11th Cir. NOV. 16, 2021). ON OCTOBER 26, 2021, THE ELEVENTH CIRCUIT DENIED REHEARING. (A COPY OF SAID ORDER IS ATTACHED HERETO AS "EXHIBIT A").

2. PURSUANT TO RULE 13.1, PETITIONER CURRENTLY HAS 90 DAYS ON UNTIL MONDAY, JANUARY 24, 2022, TO FILE HIS PETITION FOR WRIT OF HABEAS CORPUS.

3. PURSUANT TO RULES 13.5, 22, AND 30.3, PETITIONER APPLIES FOR A SIXTY(60)-DAY EXTENSION OF TIME, FROM MONDAY, JANUARY 24, 2022, UNTIL FRIDAY, MARCH 25, 2022, TO FILE HIS PETITION FOR WRIT OF HABEAS CORPUS.

4. PETITIONER NEEDS AN EXTENSION FOR THE FOLLOWING REASONS:

5. FIRST, HE IS INCARCERATED AND PROCEEDING PRO SE.

6. SECOND, HE HAS ONLY LIMITED LAW LIBRARY ACCESS.

7. THIRD, IN BAKER V. TOOLE, ___ U.S. ___, 138 S.Ct. 234 (2017), THIS COURT ORDERED THAT HE COULD NOT FILE ANY FURTHER PETITIONS UNLESS THE FILING FEE WAS PAID AND THE PETITION IS SUBMITTED PURSUANT TO RULE 33.1 (BOOKLET FORMAT). PETITIONER INTENDS TO PAY THE FILING FEE AND TO SUBMIT HIS PETITION IN BOOKLET FORMAT, HOWEVER, IN HIS PLACE OF INCARCERATION, HE DOES NOT HAVE ACCESS TO RESOURCES TO PRINT OR BIND SUCH BOOKLETS. THUS, HE MUST USE

AN OUTSIDE COMMERCIAL PRINTING COMPANY TO PRINT THE BOOKLETS.

8. FURTHER, PETITIONER DOES NOT HAVE ACCESS TO A NON-COLLECT PHONE
W/WHICH TO COMMUNICATE W/ A PRINTING COMPANY, THUS ALL HER
COMMUNICATIONS W/ THE PATIENT ARE HAVING TO GO THROUGH
AN OUTSIDE FRIEND.

9. FURTHER, SAID OUTSIDE FRIENDS RECENTLY SUFFERED A DEATH
IN HER FAMILY AND HAS NOT BEEN RECENTLY AVAILABLE TO
COMMUNICATE BETWEEN PETITIONER AND THE PATIENT.

10. WHEREFORE, PETITIONER REQUESTS FOR A SIXTY(60) DAY
EXTENSION OF TIME, FROM MONDAY, JANUARY 24, 2022, UNTIL
FRIDAY, MARCH 25, 2022, TO FILE HER PETITION FOR WRIT OF
CERTIORARI.
