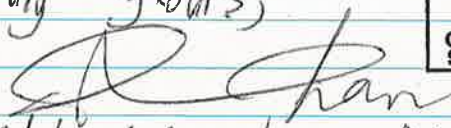
MY REQUEST FOR EXTENSION

Please be on notice that I need/I am requesting for an extension of time of 60 days to file an appeal or also known as a petition for a writ of certiorari in this court. The cause of this request is that on 11/15/2021 I was taken on a court trip from Midstate correctional facility (my prior housing facility) to Auburn correctional facility for the court trip. The court trip at Auburn C.F.²⁾ was completed on 11/27/2021 but en route back to Midstate C.F.²⁾ and while at Ulster C.F.²⁾ prison officials learned that everyone (including I) on the bus to Ulster C.F.²⁾ were exposed to an individual whom is COVID-19 positive and then we all were subjected to a 10-14 days quarantine; But then New York State Department of corrections and community supervision decided to relocate I to a different prison facility and not to take I back to Midstate C.F.²⁾ where Midstate C.F.²⁾ was where my property were stored at. But on 12/22/2021 was when I received my property; And on 12/24/2021 was when I received the legal mail of sent by this court which included rules and petition for a writ of certiorari blank forms in which I requested for; However more significantly upon the U.S. Court of Appeals 2nd circuit's order of 9/30/2021 that denied my appeal or dismissed my appeal and upon the same court's order of 10/21/2021 that denied my petition for a rehearing on the 9/30/2021 order, no court sent to I the needed forms and updated rules to begin a writ of certiorari petition as that is the practice I am known to in pursuant to my past litigations with this U.S. Supreme court and the lower court. And I waited patiently until I started noticing that no court has sent I the needed papers (forms) rules to begin the petition timely. And for so I sent to the U.S. District Court Northern District of New York and this court to send the needed of I, in which the lower court sent to I rules of such Northern District of New York and then the U.S. Supreme court sent to I¹⁾ in which I received it on 12/24/2021 due to it being sent to Midstate C.F.²⁾ and Midstate C.F.²⁾ had to send it to my current housing facility). And since I just arrived at Great meadow C.F.²⁾ on 12/14/2021 it will take about 30 days to adjust.¹⁾

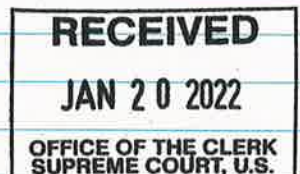
