

COMES NOW the Appellant-Petitioner in this Matter to file an expedited motion for a brief extension of time to file this petition for a writ of Certiorari.

Appellant-Petitioner's application for certiorari is due Monday, January 3. Appellant-Petitioner believes that this case and the issue presented here is of exceptional importance to the administration of law in this jurisdiction. Appellant-Petitioner is appearing *pro se* and has been working diligently through the holiday and religious observances to submit his brief for consideration. Appellant-Petitioner had made arrangements with a printer to prepare the Appendix over the weekend of January 1-2, 2022 and an expedited printing and submission on January 3. Unfortunately, on December 31, 2021 Appellant-Petitioner's wife (life partner) tested positive for Covid-19 and Appellant-Petitioner spent the entire weekend, including December 31, securing doctor assistance, a prescription for Paxlovid, and the medicine required, as well as tend to his wife, who was very sick with symptoms.
