


### APPLICATION FOR EXTENSION OF TIME

Pursuant to Rule 13.5 of the Rules of this Court, Applicant O.C. requests a 60-day extension of time, under extra-ordinary circumstances, to file a petition for a writ of certiorari to the Supreme Court of Ohio.

### JUDGEMENT FOR WHICH REVIEW IS SOUGHT

The judgement for which review is sought is V.C. v. O.C., Case # 2021-0736 9 (attached as Exhibits A and B). The Supreme Court of Ohio denied applicant's request for reconsideration of its decision not to review the decision of the 8<sup>th</sup> District Appellate Court, on November 9, 2021.

### JURISDICTION

The court has jurisdiction over a petition for certiorari in this case, pursuant to 28 US § 1257 (a).

### REASONS JUSTIFYING THE EXTENSION OF TIME

Applicant respectfully request for a 60-day extension of time within which to file a petition for a writ of certiorari in this case, because he was involved in an exceptional circumstance that delayed his preparation for the petition. On December 23, 2021, two of his minor children and their mother were diagnosed with Covid-19. He had to take care of the children until after the second week of January 2022. He also had to contend with the rising cases of Covid-19 at the Department of Veteran Affairs Medical Center, where he works as a physician.

It is my humble opinion that our children deserve to be raised by both of their competent parents and that both parents deserve equal right for fair hearing under the law, in accordance with the 14<sup>th</sup> Amendment of the US Constitution. Whereas, the applicant, believes that both fatherhood and motherhood are important in the upbringing of our children, he witnessed unlawful and unconstitutional suppression of his parental rights in the denial of his petition for reconsideration by the Supreme Court of Ohio.

Applicant wishes to demonstrate that this case is of great public interest currently in the history of our nation, but he was delayed from doing so, by extra-ordinary circumstances. He therefore respectfully requests for a 60-day extension of time to enable him to prepare and file his petition for a writ of Certiorari to the Supreme Court of the State of Ohio.
