
THE PETITIONER(S) GIVE THE UNITED STATES SUPREME COURT JUDICIAL NOTICE THAT THE REASON McCRAY'S NAME DOES NOT APPEAR ON THE ORDER IS BECAUSE THE COURT(S) IN FRAUD FAILED TO RULE ON THE MOTION TO INTERVENE FILED BY McCRAY AND THE DISTRICT COURT INAPPROPRIATELY SEPARATED McCRAY FROM THE LOWER COURT WHICH WAS A QUESTION THAT WAS TO BE PLACED BEFORE THE FOURTH CIRCUIT BUT IT INAPPROPRIATELY DISMISSED THE CASE FOR FAILURE TO PROSECUTE WHEN WE WERE SEEKING A STAY BEFORE THE U.S. SUPREME COURT.
