APPELLANT/PETITIONER'S MOTION FOR AN ENLARGEMENT

OF TIME TO FILE FOR A WRIT OF CERTIORARI

To The Honorable Justices Of The U.S. Sup. Ct.:

I, Appellant/Petitioner Arturo Solis, am an indigent Federal prisoner, proceeding Pro-Se without assistance and I hereby request a Ninety-(90) Day Extension Of Time, under Sup. Ct. Rule 32(2), in which I may timely file my/Petition For A writ Of Certiorari to the Tenth Circuit U.S. Court Of Appeals, in this here above identified Titled and Numbered Cause and as reason therefore and in support thereof I would show the Court the following:

(1) On Dec. 28, 2021 the Tenth Circuit U.S. Ct. App. denied my Motion For Rehearing and my Petition For Rehearing En Banc. Therefore, my deadline to file for a writ of certiorari would be upto and including MON. March 28, 2022. See: App.-A.

(2) This prison has been put on repeated lock-downs for the past over three (3) Months, most recently for the Coronavirus infections here from 1/10/2022 upto 2/15/2022; then from 2/19/2022 until 2/24/2022 for unspecified reasons; Again from 2/28/2022 upto

3/3/2022; Then again from 3/11/2022 until 3/14/2022 and then locked-down for one day on 3/15/2022, during which each lock-down I could not go to the prison law library and further the law library was kept closed without justification during the month of Jan. 2022.

(3) Additionally, I have been wrongfully denied Postage Stamps and writing and mailing materials for over one month to this present date, since Jan, 20, 2022. Needed for my legal work.

(4) I am a ~~law~~ man at law with only minimal education, therefore legal research and progress is time consuming.

(5) I ask for a Ninety (90) Day Extension of time in which I may timely file my Writ Of Certiorari in this case, from Mon. March 28, 2022 upto and including Mon. June 27, 2022.

CONCLUSION

Wherefore Premises Considered, I ask for the Court to Grant me a Ninety (90) Day extension of time in which I may timely File my Petition For A Writ Of Certiorari To The Tenth Circuit U.S. Court Of Appeals in this Case From March 28, 2022 upto and including Monday June 27, 2022.

And for the Court to Grant me any other relief to which I may be entitled under the law.
