APPLICATION FOR SIXTY (60) DAY EXTENSION OF TIME IN WHICH TO FILE
PETITION FOR WRIT OF CERTIORARI TO THE UNITED STATES COURT OF APPEALS
FOR THE NINTH CIRCUIT

COMES NOW, the Petitioner, MARK D. Colafranceschi Pro Se, and pursuant to Supreme Court Rule 13.5, respectfully requests an extension of time of sixty (60) days within which to file his Petition for Writ of Certiorari to the United States Court of Appeals for the Ninth Circuit. In support of his request, Petitioner, through counsel, states as follows:


To the Honorable Kagan Associate Justice and Circuit Justice for the Ninth Circuit: Applicant Mark D. Colafranceschi respectfully request that the time to file a petition for a writ of certiorari, in this case, be extended for 60 days, to and including April 4th, 2022,

The Idaho Supreme Court issued its opinion on January 4th, 2022 (App. A, infra),

Without an extension of time, the petition would be due on April 4th, 2022. This Court will have jurisdiction pursuant to 28 U.S.C. § 1257(a).

BACKGROUND

Mark D. Colafranceschi has been involved in divorce and family law cases in Idaho, in which Judges have been found guilty of Judicial Misconduct, and or recused with cause. Mark D. Colafranceschi has been vocal about drug use by Idaho Judges and has been retaliated upon by the Idaho judges. Resulting in a Vexatious Litigant Order



In this case Mr. Scot Ludwig and Judge Williamson conspired to deem Mr. Colafranceschi to be a vexatious litigant with evidence that they both knew to not be true.

The FBI was involved in the allegation of Neustadt/Ludwig bribing Magistrate Judge Darla Williamson before the Vexatious Litigant was executed by Scot Ludwig and Judge Darla Williamson.

The vexatious litigant case went to the Idaho Administrative Courts and then to the Idaho Supreme Court. After the Idaho Supreme Courts' final determination new court testimony proved that the vexatious litigant claims were based upon false testimony. While the vexatious order stayed in place Colafranceschi has been prohibited from appealing this case.

REASONS FOR GRANTING AN EXTENSION OF TIME

The time to file a petition for a writ of certiorari should be extended by 60 days for the following reasons:

1. Since the decision below was issued, Applicants have been considering whether to seek this Court's review and only recently decided to petition for certiorari. Julie Neustadt has made death threats to Colafranceschi that are undisputed.
2. Moreover, the Applicants has not been able to obtain all court records in this case. Additional time is necessary to study the record below and the legal issues in the case and to prepare a petition. The petition is currently due on April 4th, 2022
3. Colafranceschi is seeking legal counsel and requires additional time.
4. No prejudice would arise from the requested extension. If the petition were granted, the Court would hear an oral argument in this case. regardless of whether an extension is allowed.

CONCLUSION

WHEREFORE, Petitioner respectfully requests an extension of time of sixty days (60) within which to file the Petition for Writ of Certiorari to the United States Court of Appeals for the Ninth Circuit on the above-styled case.
