

MOTION FOR EXTENSION OF TIME

Now comes Mr. Jordan before this Honorable Court to move for an extension of time to file his petition for a writ of certiorari, and accompanying papers. Specifically, he requests the maximum extension allowable (60 days) out of an abundance of caution. (He presently understands that his petition is due on or before January 3, 2022.) In support of this motion, Mr. Jordan states the following (pursuant to 28 USC sec. 1746) under the penalty of perjury.

1. Mr. Jordan previously moved for an extension of time by motion filed on April 13, 2021. That motion was returned as unnecessary with a cover letter from the clerk (by Lisa Nesbitt) explaining that "you have 150 days from the date of the lower Court order denying a timely petition for rehearing ... to file your petition for a writ of certiorari." (Exh. A).

2. On August 6, 2021 (in Second Circuit case no. 19-2987) said petition for rehearing was denied (Exh. B).

3. Owing to the current pandemic, Mr. Jordan has no access to a law library. He is also 62-years-old and suffers from several serious, chronic, medical

conditions (including degenerative disc disease and brain lesions) that cause extreme pain and dizziness. He is pro se by financial necessity, and serving 40 years in prison after convictions for non-violent witness tampering.

4. It may be that Mr. Jordan can finish shortly before January 3, 2022, but outgoing institution mail has been problematic during the pandemic and substantially delayed.

Thus, Mr. Jordan prays this Court grant him the maximum of any available extension to file his petition.

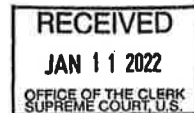


Dear Mr. Jordan:


