Point 1.) 

Point 5.) Petitioner relies on the following applicable statutes - Supreme Court rule: Ill. Sup. Ct Rule 183 that specifies "Under Rule 183, the circuit court "may extend the time for filing any pleading or the doing of any act which is required by the rules to be done within a limited period, either before or after the expiration of the time," but only "for good cause shown", and Ill. U.S. Sup. Ct. R. 30 and rule 13.4 "Extension of Time." The reviewing court or any judge thereof may extend the time for filing, in the trial court, the report of proceedings or agreed statement of facts or for serving a WRIT OF CERTIORARI proposed report of proceedings, on notice and motion filed in the reviewing court before the expiration of the original or extended time, or on notice and motion filed within 35 days thereafter motions for extensions of time shall be supported by an affidavit showing the necessity for extension, and motions made after expiration of the original or extended time shall be further supported by a showing of reasonable excuse for failure to file the motion earlier. Any motion for extension of time shall be served on the clerk preparing the record on appeal.

Point 6.) Petitioner prays that this Court grants her motion: CORRECT APPLICATION AFFIDAVIT AND MOTION FOR EXTENSION OF TIME TO FILE WRIT OF CERTIORARI primarily for the reason she is experiencing some sensitive matters that she must attend to and she needs time to fully read and understand the properly file her WRIT OF CERTIORARI. Petitioner would use Illinois Appellate court's records but there are no records on file.

Point 7.) Petitioner makes plea to this Court to allow her motion for extension of time allowed to file her WRIT OF CERTIORARI.
