JUDGMENT FOR WHICH REVIEW IS SOUGHT

The Judgment for which review is sought is *Horacio Sequeira v. Gate Safe
Inc.* No. 3D21-0487 July 21, 2021 (attached as Exhibit 1). Third District Court of
Appeal of Florida stricken the Petition for Panel Rehearing and Rehearing [En]
Banc” on August 11, 2021. (attached as Exhibit 2). My son Angel Sequeira Romero
died on October 7, 2021 and the funeral were on October 19 and 20, 2021. This case
is under investigation and pending (attached as Exhibit 3). Motion without fee be
pursuant a Court Order signed for the Clerk. (attached as Exhibit 4). A single copy
Petition for a writ of certiorari is filed as well.

JURISDICTION

This court will have jurisdiction over any timely filed petition for certiorari in
this case pursuant Rules of this court 13.1, 29.2 and 30.1 a petition for a writ of
certiorari was due to be filed on or before October 19, 2021. In accordance with the
Rule 13.5, this application is being filed more than 10 days in advance of the filing
date for the petition for a writ of certiorari.

REASONS JUSTIFYING AN EXTENSION OF TIME



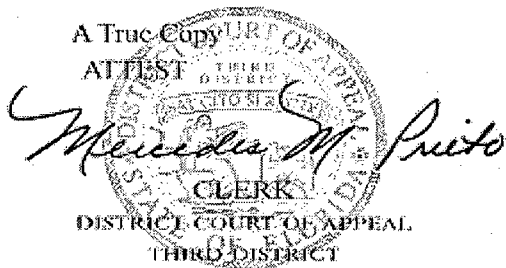
