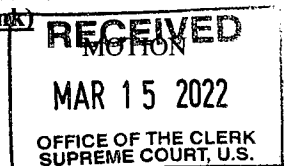

I, Marianne E Burke swear or affirm that the following facts are true to the best of my knowledge:  
I am trying to do this *Pro Se*:

1. My health has not been good for 3 yrs now, as documented in my previous Alaska Supreme Court Motions. (See Attached)

Additionally, I am older now at 61 yrs old, don't move as fast, am losing some memory, but am determined to "cross the finish line" at the very last Court of Appeal in our United States of America, in trying to get justice for my own daughter's death. Thus far, there has been no justice whatsoever for her untimely, gross negligent wrongful death in the workplace.

2. It is too short of a time left to file the Writ of Certiorari when I wasn't sure that I could or would file; it is so very difficult as a *pro se* without any attorney to help me. I tried again a month ago to find an attorney, but only one got back with me and he said that he was too inexperienced to help me.) (See page 2)

Most all attorneys won't help me because they don't think that they can win. I did have an attorney friend who represented me at the Alaska Superior Court level (Attorney Keven Dougherty), and of whose many documents I will use in this appeal. But he planned and did retire about 3 yrs ago.

Additionally, the US Supreme Court Rules of the Court are very detailed and very difficult for me to sort through as a *pro se* in order to understand; not just *how* to file this document, but what its content, argument, and appendices are to be.

3. I am financially not able to use Cockle Legal Briefs as I did 3 yrs ago in the suit against the employer (# 18-8191, to no avail). I had to pay for all of that with credit cards and am now trying to get out of a lot of credit card debt.

I am therefore, planning on printing all of the pages for the 40+ booklets *myself* (which I think will be at least 100 pp each), using the formatting of the previous Cockle Legal Brief's filing to hopefully meet the formatting rules of the court, and then I will take these pages to the printer to have them cut and bind the booklets according to the Court's specifications.

That could take days just to get this printing job done.
