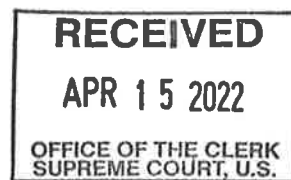
BECAUSE:

1. I was sick for a whole week this last 30 days. I don't know what I had, but I didn't have any energy, mental clarity, had a headache, aches and pains. I will rarely see doctors, so attached is my husband testifying to my sickness.

2. My dog had major surgery 2 weeks ago and had to be watched 24/7, making it very difficult for me to work on the Certiorari (see surgery paper work attached). She had a large tumor removed on her abdomen. She is still needing continual care, as some infection developed, so this continues to slow my certiorari progress down. Attached picture of her wound that is still a little infected and continues to need care.

3. This is a monumental task for me in trying to figure out formatting, content, legal argument, etc to complete this by myself! I am going thru the certiorari page by page to get correct formatting, margins, legal content and a decent legal argument on my own (pro se). I did come up with a good argument, but I see that I need to add more court documents and law sources to substantiate my argument. This will take me more time for research.
