Dear Mr. Harris,

I am counsel for Respondent Foresight Coal Sales, LLC ("Respondent"), in this case. Petitioners filed their Petition on May 4, 2023. On May 19, 2023, Respondent waived its right to respond. On June 6, 2023, however, the Court requested a response. Absent an extension, Respondent's response is due on July 6, 2023. Pursuant to Rule 30.4, Respondent respectfully requests that the time for filing a response be extended by thirty days. Because a thirty-day extension of time would make Respondent's brief due on Saturday, August 5, 2023, Respondent respectfully requests a due date of August 7, 2023.

This request for an extension is Respondent's first. Good cause exists for the requested extension. Respondent's counsel has numerous other professional commitments prior to the current deadline, including an oral argument on June 16, 2023, and an opening brief for a case in the U.S. Court of Appeals for the Ninth Circuit due on July 7, 2023. The requested extension is necessary to ensure Respondent and its counsel have an adequate opportunity to review and respond to the Petition for a Writ of Certiorari in light of these other commitments.
