Dear Mr. Harris:

I write on behalf of all parties to request an extension of the briefing deadlines in this case. The Court granted the petition for a writ of certiorari on February 27, 2023. I understand that the case is likely to be argued during the Court's October 2023 sitting. Petitioner's opening merits brief is currently due April 13, 2023.
