APPLICATION FOR AN EXTENSION OF TIME TO FILE A PETITION FOR A WRIT OF CERTIORARI TO THE UNITED STATES COURT OF APPEALS FOR THE SIXTH CIRCUIT

To the Honorable Brett Kavanaugh, Associate Justice of the Supreme Court and Circuit Justice for the Sixth Circuit:

1. Pursuant to Supreme Court Rules 13.5, 22, and 30, Applicants Georgia-Pacific Consumer Products LP, Fort James LLC, and Georgia-Pacific LLC (collectively, "Georgia-Pacific"),² respectfully request a 33-day extension of time, up to and including November 14, 2022, to file a petition for a writ of certiorari to the United States Court of Appeals for the Sixth Circuit, seeking review of that court's decision in *Georgia-Pacific Consumer Products LP v. NCR Corp.*, 32 F.4th 534 (6th Cir. 2022). The Sixth Circuit issued its decision on April 25, 2022, and denied a

timely rehearing petition on July 14, 2022. See 40 F.4th 481 (6th Cir. 2022). These orders are attached as Appendix A and Appendix B, respectively. The jurisdiction of this Court will be invoked under 28 U.S.C. § 1254(1), and the time to file a petition for a writ of certiorari will otherwise expire on October 12, 2022. This Application is timely because it has been filed on August 29, 2022, more than ten days prior to the date on which the time for filing the petition is to expire.

2. Applicants have good cause for an extension of time. Georgia-Pacific has recently retained the law firm of Jones Day to prepare the petition for certiorari on its behalf. Given its experience and expertise in this area, Jones Day is well positioned to prepare a petition that will assist this Court in evaluating the case and the issues presented. The quality of the petition would greatly benefit from an extension of time to allow Jones Day to complete the requisite research and writing.

WHEREFORE, Applicants respectfully request that an order be entered extending the time to file a petition for a writ of certiorari for 33 days, to and including November 14, 2022.
